

The G30 is a group of thirty bankers and economists with high level authority over global finance. The Rockefeller family financed the creation of the G30. 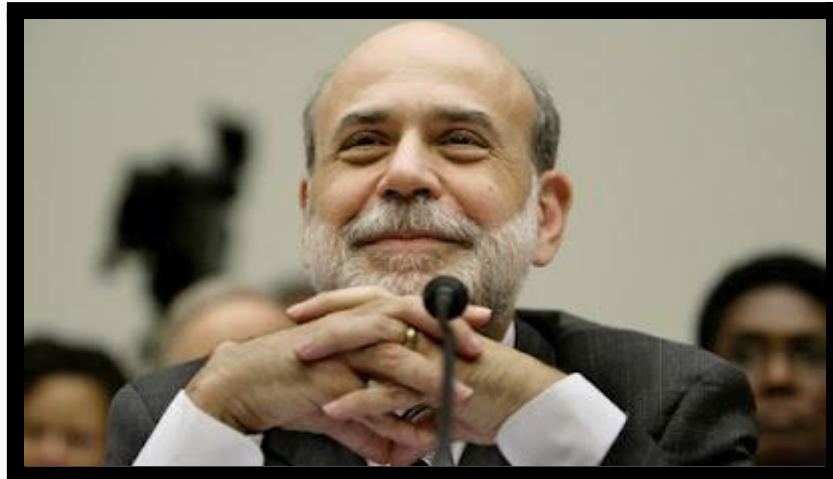

Jean-Claude Trichet was former President of the European Central Bank and Honorary Governor of Banque de France and is Chairman of the European Group of the Trilateral Commission and is a Commandeur de la Légion d'Honneur.



Leszek Balcerowicz is a Professor at the Warsaw School of Economics and is a Polish Knight of the Order of the White Eagle a knighthood created by the House of Wettin. Balcerowicz is an Eastern European financial authority working under the House of Saxe-Weimar-Eisenach the current Dukes of Wettin.



Ben Bernanke was Chairman of the Board of Governors of the Federal Reserve System and is a British Crown Harvard agent. Bernanke has a high authority in international banking and works for the Rothschilds and Goldsmiths of London.



Mark Carney is the Governor of the Bank of England and Chair of the Monetary Policy Committee. He worked 13 years at Goldman Sachs. He is a British Crown Harvard agent and received a Jesuit high school education.

Mario Draghi is President of the European Central Bank and is on the Board of Directors of the Bank for International Settlements. Draghi was Jesuit educated from Massimiliano Massimo Institute and is Rome's top banker. Draghi is a relative of the Borghese and Del Drago families and also works under the Massimo and Torlonia families.



William C. Dudley is the former president and chief executive officer of the Federal Reserve Bank of New York and partner and managing director at Goldman Sachs and was the firm's chief U.S. economist for a decade. Dudley works for the Bavarian House of Wittelsbach

through his work with Goldman Sachs a bank founded by Bavarian bankers.



Roger W. Ferguson, Jr. was Vice Chairman of the Board of Governors of the U.S. Federal Reserve System. Ferguson is a British Crown agent through his education at Yale.



Arminio Fraga is the founding partner at Gavea Investimentos of Brazil and was the President of the Central Bank of Brazil. He was Managing Director of Soros Fund Management. Fraga was Jesuit educated at the Catholic University of Rio de Janeiro and is an agent of the Brazilian Royal House of Orleans-Braganza.



Timothy Geithner is currently President of Warburg Pincus, was President and Chief Executive Officer of the Federal Reserve Bank of New York and is on the Board of Directors of the Council on Foreign Relations. Geithner is a British Crown agent through his education at Yale.



Gerd Hausler is Chairman of the Supervisory Board of the Bavarian Bayerische Landesbank, and was Director of the International Capital Markets Department of the IMF, was a Member of the Board of Managing Directors at Dresdner Bank AG, and has worked at Lazard and the Hessian Deutsche Bundesbank. Hausler is an agent of various German royals including the House of Hesse and the Bavarian House of Wittelsbach.



Philipp Hildebrand is Vice Chairman of BlackRock which is the largest asset management company with over \$6 trillion in assets

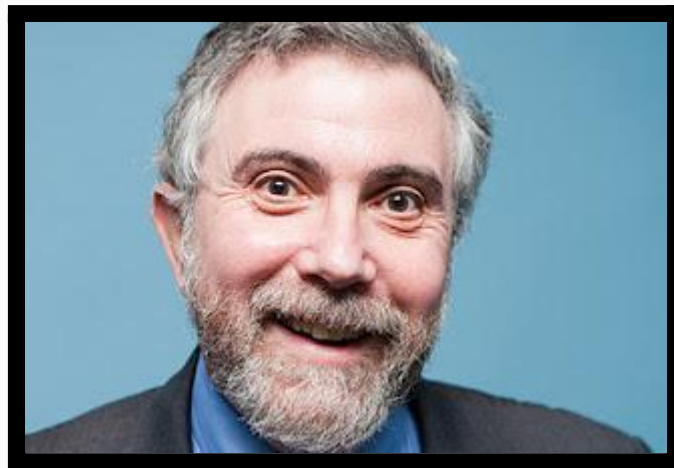
under management. Hildebrand was also a Director of the Bank for International Settlements and was Chairman of the Governing Board of the Swiss National Bank until he resigned due to allegations of insider trading and the one that reported on him was arrested for breaking Swiss banking secrecy laws. His girlfriend is the billionaire Margarita Louis-Dreyfus and chairperson of Louis Dreyfus Group. The Dreyfus family are agents of the Dutch House of Orange-Nassau with their company headquartered in the Netherlands.



Gail Kelly is a Senior Global Advisor to UBS. She was Managing Director of St. George Bank and Westpac. Kelly is an British Crown agent through her education at the University of New South Wales.



Mervyn King was Governor of the Bank of England and is a Knight of the British Empire and British Knight of the Order of the Garter. He is a noble baron in the City of London Corporation and works with the Rothschilds, Goldsmiths, and Montagu family which were co-founders of the Bank of England.



Paul Krugman has been a consultant to the Federal Reserve Bank of New York, the World Bank, the International Monetary Fund, and the United Nations. He is a British Crown agent through his work at Yale and a Dutch Crown agent through his work at Princeton.



Christian Noyer was a former Governor of the Banque de France, former chairman of the Bank for International Settlements, and has been an alternate Governor at the International Monetary Fund. Noyer is a French Crown agent through the House of Bonaparte's Legion of Honour.



Raghuram G. Rajan was Governor of the Reserve Bank of India and was the Chief Economist and Director of Research at the International Monetary Fund. Rajan was educated at the Chicago Booth School of Business.



Maria Ramos is Chief Executive Officer of Barclays Africa Group and was the Group Chief Executive of Transnet Ltd the South African state-owned freight transport and logistics service. She is a British Crown agent through the University of London and works with Quaker bankers in the UK like the Barclay family. The Barclay family are also British nobles and another branch are British businessmen and billionaires. Transnet like most major transportation companies is involved with human trafficking. Transnet has been sued for stealing pensions as well.



Kenneth Rogoff is a Professor of Economics at Harvard University and a British Crown agent. Rogoff works as an adviser and

strategist for central bankers. The British Crown created Harvard through a royal charter.



Masaaki Shirakawa is the former Governor of the Bank of Japan and agent of the royal family of Japan which are British Crown knights of the Order of the Garter. Shirakawa was also Vice-Chairman of the Board of Directors of the BIS.



Lawrence Summers is a Professor at Harvard University and a British Crown agent. Summers was Secretary of the Treasury during the Clinton Administration and the Director of the White House National Economic Council during the Obama Administration.



Tidjane Thiam is Chief Executive Officer of Credit Suisse Group AG and is a French Crown agent as a member of the Bonaparte's Legion of Honour.



Adair Turner chaired the UK's Financial Services Authority, was vice-Chairman of Merrill Lynch Europe, professor at the London School of Economics, fellow of the Royal Society, and Chairman of the Governing Board for the Institute for New Economic Thinking. Turner is a British noble in Ecchinswell.



Kevin Warsh was on the Board of Governors of the Federal Reserve System and is a British Crown agent through his education at Harvard. Warsh has also worked with the Bank of England.



Axel A. Weber is the Chairman of UBS Group and Chairman of the Institute of International Finance. Weber is also a Board Member of the Swiss Bankers Association and International Monetary Conference. He is also a member of the Trilateral Commission. Weber is a top international banker and an agent of the German and Italian nobles through their Warburg bankers which partly created UBS and through his education from various German universities which were established by royal families in Germany including the Nassaus-Weilbergs of Luxembourg and Habsburgs of Austria as well as the University of Cologne which was established by the Papacy.



Yi Gang is the Governor of the People's Bank of China and is on the Board of Directors of the Bank for International Settlements. Gang was educated in the United States and works with the royal Yi family of China and their Triad gangs. The British Crown has leverage over China through its literal and now covert control over Hong Kong.



Ernesto Zedillo is the Director of the Yale Center for the Study of Globalization and a British Crown agent. Zedillo is a member of The Elders and Chair of the High Level Commission on Modernization of World Bank Group Governance. Zedillo was also a former President of Mexico and works under the Spanish House of Bourbon which have recent shared Battenberg ancestry with the British royal family.



Zhou Xiaochuan is Vice Chairman of the Boao Forum for Asia and is Governor for China to the International Monetary Fund, on the Board of Directors of the Bank for International Settlements and is also Governor for the African Development Bank, the Inter-American Development Bank, and the European Bank for Reconstruction and Development which are involved in buying off nations. Zhou is a communist and works with the royal family of China and was also educated in the United States.

The **Group of Thirty**, often abbreviated to G30, is an international **body of leading financiers** and academics which aims to deepen understanding of economic and financial issues and to examine consequences of decisions made in the public and private sectors related to these issues.

The **Group of Thirty** was founded in 1978 by **Geoffrey Bell** at the initiative of the **Rockefeller Foundation**,^[2] which also provided initial funding for the body.



Stuart Mackintosh is the Executive Director of the G30 and was educated at the University of Edinburgh a college officially established by a royal charter under the Stuart King James VI and is an agent of the House of Stuart.



Guillermo Ortiz with Geoffrey Bell the founder of the Group of Thirty who worked as Chairman of Guinness Mahon Bank a bank owned and founded by the Irish Guinness banking family which have intermarried with the Rothschilds. The Rockefeller Foundation was an original financier of the G30.

Between 1966 and 1969, he served as **economic advisor to the British Embassy in Washington**, then joined the **Schroders Bank**, as assistant to the Chairman, Gordon Richardson, later Bank of England Governor. He was **chairman of the bank Guinness Mahon Holdings** between 1987 and 1993.
