In order to circumvent this crisis a fictional corporation called THE UNITED STATES OF AMERICA was filed for and created in the Sovereign Nation of France in 1871. This fictional entity was deemed a "Legislative Democracy" and has a different constitution that was enacted by and accepted "on the behalf of the people" by agents representing this fictional corporation.
